



Terms and Conditions

Ownership of Site and agreement to Terms of Use

These Terms and Conditions of Use (the “Terms of Use”) apply to the Quimera web site located at www.quimera-project.com. The Site is the property of Quimera Project S.L. (“Quimera”). By using the site, you agree to these terms of use; if you do not agree, do not use the site.

Quimera reserves the right, at its sole discretion, to change, modify, add or remove portions of these Terms of Use, at any time. It is your responsibility to check these Terms of Use periodically for changes. Your continued use of the Site following the posting of changes will mean that you accept and agree to the changes. As long as you comply with these Terms of Use, Quimera grants you a personal, non-exclusive, non-transferable, limited privilege to enter and use the Site.

Content
